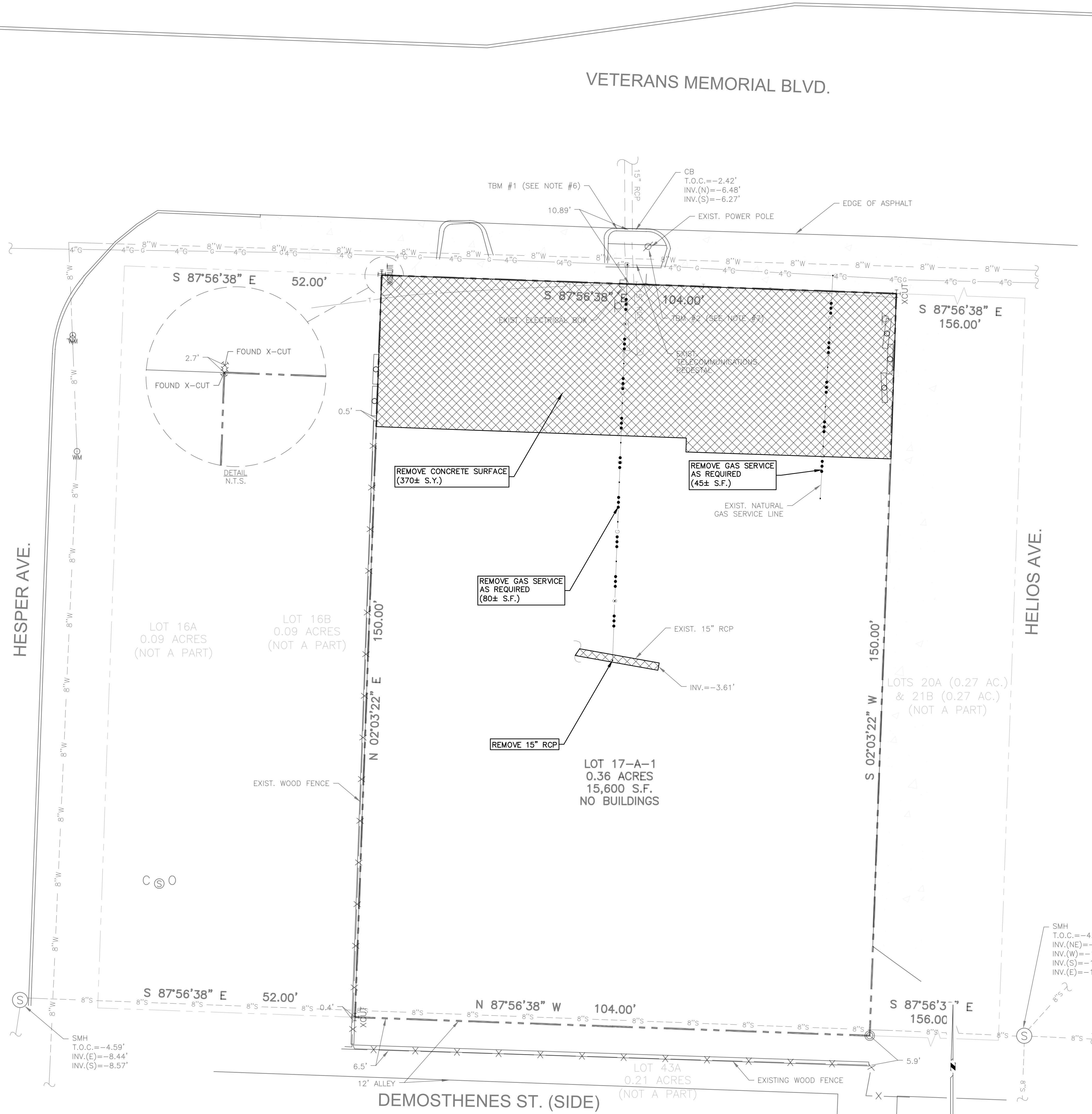

2 DEMOLITION NOTES

1. 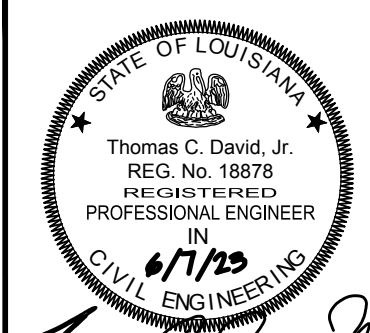

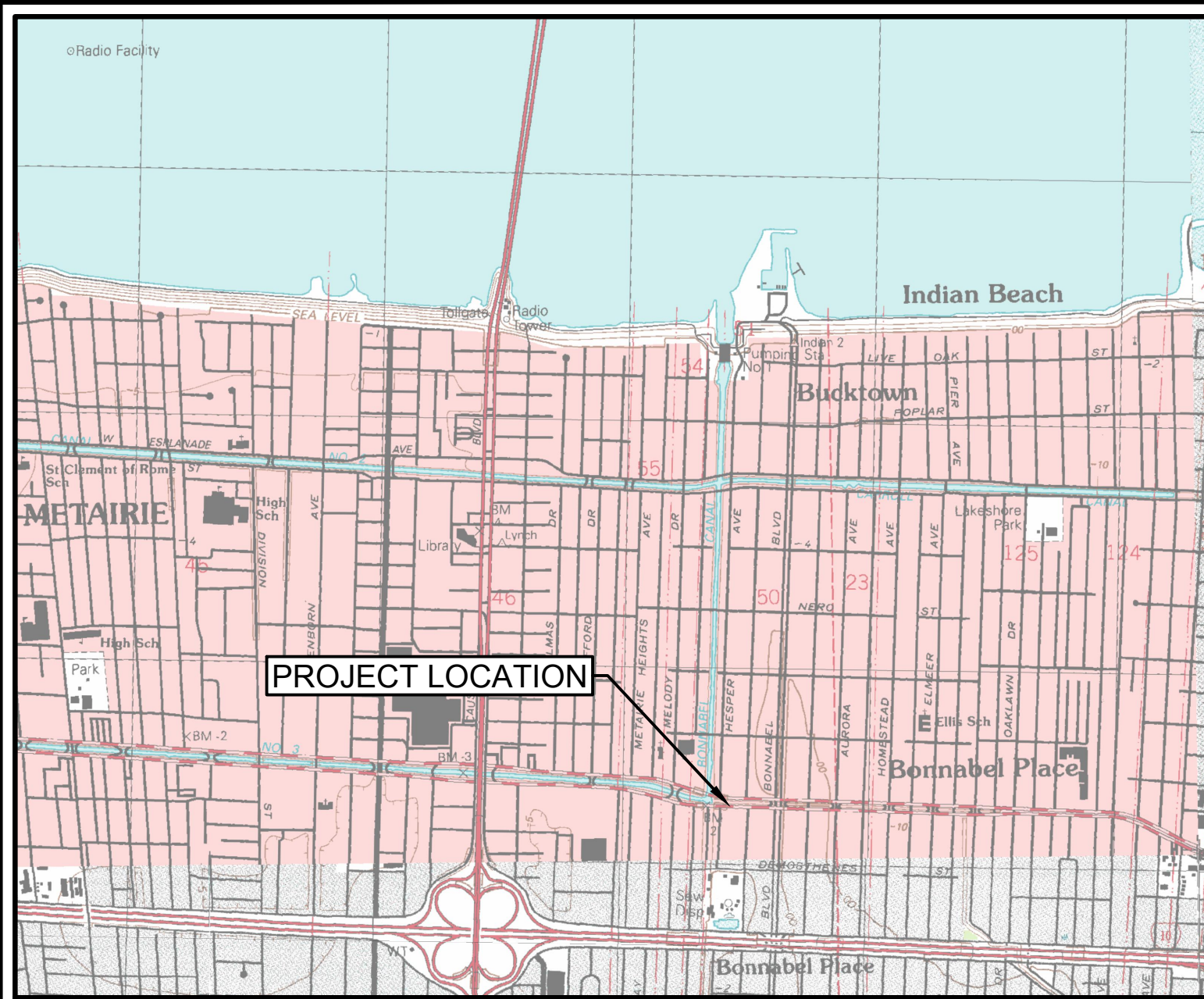

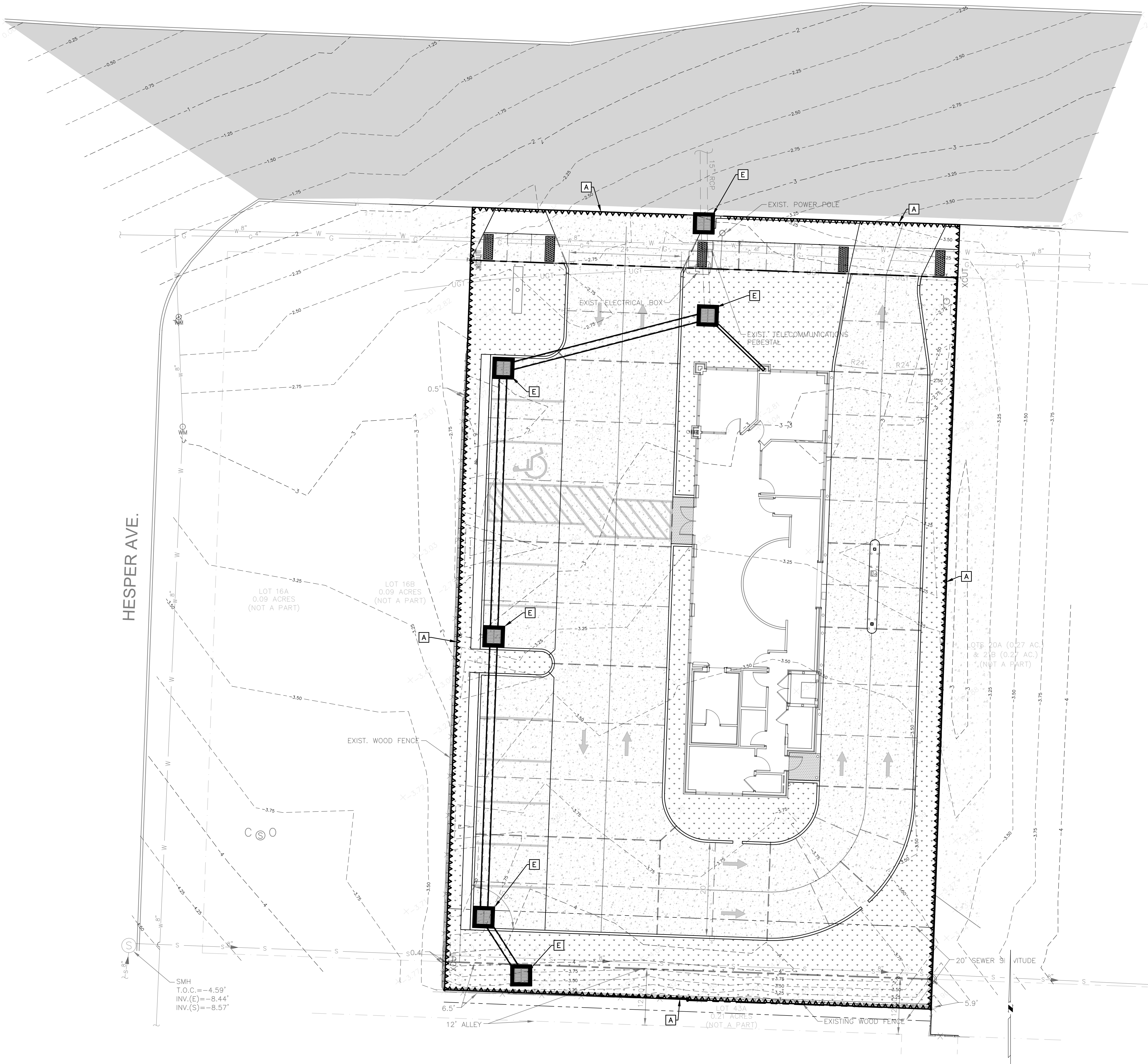
2 GENERAL NOTES

- CONTRACTORS AND SUBCONTRACTORS INVOLVED WITH STORM WATER POLLUTION PREVENTION SHALL OBTAIN A COPY OF THE STORM WATER POLLUTION PREVENTION PLAN AND THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM GENERAL PERMIT (NPDES GENERAL PERMIT) AND BECOME FAMILIAR WITH THEIR CONTENTS. IN THE CASE THAT THE NPDES GENERAL PERMIT REQUIREMENTS CONFLICT WITH ANY REQUIREMENTS SHOWN HEREON, THE NPDES GENERAL PERMIT SHALL TAKE PRECEDENCE AND BE FOLLOWED.
- THE TEMPORARY PARKING AND STORAGE AREA SHALL ALSO BE USED AS THE EQUIPMENT MAINTENANCE AREA, EQUIPMENT CLEANING AREA, EMPLOYEE BREAK AREA, AND AREA FOR LOCATING PORTABLE FACILITIES, OFFICE TRAILERS, AND TOILET FACILITIES. THE EXACT LOCATIONS SHALL BE COORDINATED WITH THE OWNER'S CONSTRUCTION MANAGER.
- WASH WATER (CONCRETE TRUCKS, VEHICLE CLEANING, EQUIPMENT CLEANING, ETC.) SHALL BE DISPOSED OF IN A MANNER THAT PREVENTS CONTACT BETWEEN THESE MATERIALS AND STORM WATER THAT IS DISCHARGED FROM THE SITE.
- MAINTAIN ON THE SITE OR HAVE READILY AVAILABLE SUFFICIENT OIL AND GREASE ABSORBING MATERIALS AND FLotation BOOMS TO CONTAIN AND CLEAN-UP FUEL OR CHEMICAL SPILLS AND LEAKS.
- DUST ON THE SITE SHALL BE CONTROLLED BY SPRAYING WATER ON DRY AREAS OF THE SITE. THE USE OF MOTOR OILS AND OTHER PETROLEUM BASED OR TOXIC LIQUIDS FOR DUST SUPPRESSION OPERATIONS IS PROHIBITED.
- NO RUBBISH, TRASH, GARBAGE, OR OTHER SUCH MATERIALS SHALL BE ALLOWED TO DISCHARGE INTO DRAINAGE DITCHES OR WATERS OF THE STATE.
- STORM WATER POLLUTION PREVENTION MEASURES PRESENTED ON THIS PLAN, AND IN THE STORM WATER POLLUTION PREVENTION PLAN, SHALL BE INITIATED AS SOON AS PRACTICABLE.
- DISTURBED PORTIONS OF THE SITE WHERE CONSTRUCTION ACTIVITY WILL BE STOPPED FOR AT LEAST 21 DAYS, SHALL BE TEMPORARILY SEEDDED WITHIN 14 DAYS.
- DISTURBED PORTIONS OF THE SITE WHERE CONSTRUCTION ACTIVITY HAS PERMANENTLY STOPPED SHALL BE PERMANENTLY SEEDDED. THESE AREAS SHALL BE SEEDDED NO LATER THAN 14 DAYS AFTER THE LAST CONSTRUCTION ACTIVITY OCCURRING IN THESE AREAS.
- IF THE ACTION OF VEHICLES TRAVELING OVER THE GRAVEL CONSTRUCTION ENTRANCES IS NOT SUFFICIENT TO REMOVE THE MAJORITY OF DIRT OR MUD, THEN THE TIRES MUST BE WASHED BEFORE THE VEHICLES ENTER A PUBLIC ROAD. IF WASHING IS USED, PROVISIONS MUST BE MADE TO INTERCEPT THE WASH WATER AND TRAP THE SEDIMENT BEFORE IT IS CARRIED OFF THE SITE. THE EXACT LOCATIONS SHALL BE COORDINATED WITH THE OWNER'S CONSTRUCTION MANAGER.
- MATERIALS SPILLED, DROPPED, WASHED, OR TRACKED FROM VEHICLES ONTO ROADWAYS OR INTO STORM DRAINS MUST BE REMOVED IMMEDIATELY.
- CONSTRUCT SILT FENCES, SILT DIKES, OR OTHER PHYSICAL BARRIERS AS NECESSARY AROUND DISTURBED AREAS TO CONTROL EROSION AND SILTATION.
- IF SOIL STOCKPILING IS EMPLOYED ON THE SITE, SILT FENCES SHALL BE USED TO CONTAIN THE SEDIMENT.
- SLOPES AND AREAS DISTURBED BY CONSTRUCTION SHALL BE GRADED SMOOTH AND 4" OF TOPSOIL APPLIED. IF ADEQUATE TOPSOIL IS NOT AVAILABLE ON SITE, THEN PROVIDE TOPSOIL, AS NEEDED. THE AREA SHALL THEN BE SEEDDED, FERTILIZED, MULCHED, WATERED AND MAINTAINED UNTIL GRASS GROWTH IS ESTABLISHED IN ALL AREAS. ANY AREAS DISTURBED FOR ANY REASON PRIOR TO FINAL ACCEPTANCE OF THE PROJECT SHALL BE CORRECTED BY THE CONTRACTOR AT NO ADDITIONAL COST TO THE OWNER.
- TEMPORARY EROSION AND SEDIMENT CONTROL MEASURES SHALL BE DISPOSED OF WITHIN 30 DAYS AFTER FINAL STABILIZATION. FINAL STABILIZATION HAS OCCURRED WHEN ALL SOIL DISTURBING ACTIVITIES ARE COMPLETED AND A UNIFORM PERENNIAL VEGETATIVE COVER WITH A DENSITY OF 70% OF THE COVER FOR UNPAVED AREAS AND AREAS NOT COVERED BY PERMANENT STRUCTURES HAS BEEN EMPLOYED.
- THE CONTRACTOR IS RESPONSIBLE FOR ADJUSTING THE EROSION CONTROL MEASURES (SILT FENCES, INLET PROTECTION, ETC.) AS NECESSARY DURING CONSTRUCTION TO HELP PREVENT EROSION AND STORM WATER POLLUTION.
- OFF-SITE CONSTRUCTION, IF PERFORMED, SHALL BE STABILIZED AT THE END OF EACH WORKING DAY. THIS INCLUDES BACKFILLING OF TRENCHES FOR STORM DRAINS & UTILITY CONSTRUCTION, ETC.

3 NATURE OF ACTIVITY / CONSTRUCTION SEQUENCE

THIS PROJECT GENERALLY INCLUDES, BUT IS NOT LIMITED TO, THE FOLLOWING CIVIL SITE WORK AND RELATED APPURTENANCES:

- INSTALLATION OF STORM WATER POLLUTION PREVENTION PLAN BEST MANAGEMENT PRACTICES.
- DEMOLITION/REMOVAL OF VARIOUS PAVEMENT/BASE, CURBS, CURB AND GUTTER, WALKS, STORM DRAINS, UTILITIES, LANDSCAPING, ETC. TO FACILITATE CONSTRUCTION OF THE PROJECT.
- REMOVAL OF ABANDONED UTILITIES AND ELECTRICAL CONDUITS AND WIRING.
- INSTALLATION OF EXCAVATION AND EMBANKMENT AND ELECTRICAL UTILITIES FOR ROADWAY CONSTRUCTION.
- INSTALLATION OF NEW STORM DRAINAGE PIPE AND STRUCTURES.
- INSTALLATION OF ROADWAY PAVEMENT AND UTILITIES.
- INSTALLATION OF STRIPING ON NEW PAVEMENT AREAS.
- STABILIZATION OF DISTURBED UNPAVED AREAS.
- REMOVE TEMPORARY STRUCTURAL CONTROLS.

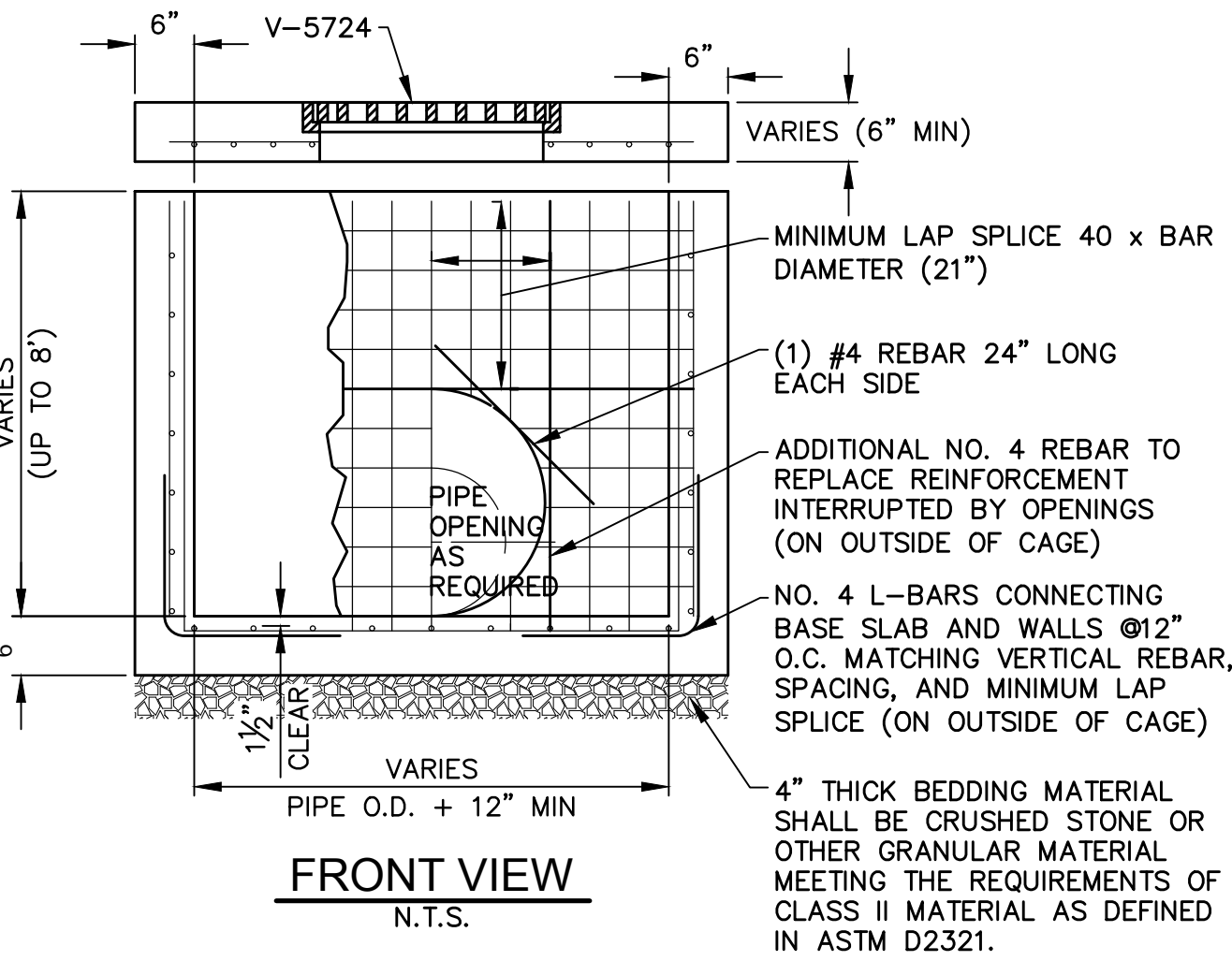

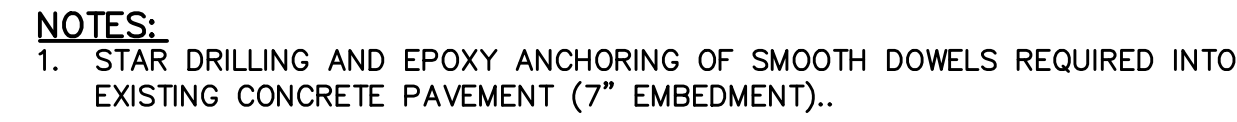

1. AREA STEEL CALCULATED WITH ENGINEERED MAT & REBAR DESIGNED TO MEET REQUIRED AREA OF STEEL. ALL GRADE 60 MINIMUM.
2. AREA OF STEEL APPLIES TO BOTH DIRECTIONS & AT ALL LOCATIONS.
3. CLASS 1 CONCRETE WITH DESIGN STRENGTH OF 5000 PSI AT 28 DAYS.
4. PIPE TO BE GROUTED IN BY CONTRACTOR AFTER INSTALLATION.

2. BEDDING (LOUISIANA STANDARD SPECIFICATIONS FOR ROADS AND BRIDGES—2006 EDITION, SECTION 1003.08) COMPACTED TO 95% STANDARD PROCTOR DENSITY. MAXIMUM PARTICLE SIZE SHALL BE 60# AND SHALL BE SHAPED TO THE BOTTOM OF THE PIPE.
3. HAUNCHING AND INITIAL BACKFILL MATERIAL FOR FLEXIBLE PIPE SHALL BE CLASS II OR I GRANULAR (REF. ASTM D2321) SHALL HAVE A VOID RATIO (E_v) OF 1.0 OR LESS THAN THAT OF THE BEDDING MATERIALS AND SHALL BE COMPACTED TO 95% STANDARD PROCTOR DENSITY. MAXIMUM OPTIMUM MOISTURE CONTENT (ASTM D698).
4. BEDDING, HAUNCHING, INITIAL BACKFILL AND SELECT FILL SHALL BE IN ACCORDANCE WITH THE PIPE MANUFACTURER'S RECOMMENDATIONS. THE SELECT FILL SHALL BE FREE OF ORGANIC OR OTHER DELETERIOUS MATERIALS, HAVE A MAXIMUM PARTICLE SIZE OF LESS THAN 3" AND A MAXIMUM MOISTURE CONTENT OF LESS THAN 1% PLASTICITY INDEX BETWEEN 8 AND 20, AND LESS THAN 6% PASSING THE NO. 200 SIEVE.
5. SELECT FILL SHALL BE PLACED IN 8" MAX. LOOSE LAYERS COMPACTED TO 95% STANDARD PROCTOR AT -1% TO +3% OPTIMUM MOISTURE CONTENT (ASTM D698).



1. PRECAST CONCRETE CATCH BASINS SHALL BE UTILIZED ON THIS PROJECT. THE PRECAST CONCRETE CATCH BASIN SHALL MEET THE REQUIREMENTS OF SECTION 702.02 OF THE MISSOURI STANDARD SPECIFICATIONS FOR ROADS AND BRIDGES, 2006 EDITION. C.B.'S WITH MASONRY WALLS SHALL BE GROUTED 1/2" ON THE INSIDE AND OUTSIDE.
2. THE BOTTOMS OF CATCH BASINS SHALL CONTAIN BENCHES AND THEY SHALL BE CONSTRUCTED TO ALLOW SMOOTH FLOW THROUGH THE SYSTEM. GROUT SHALL EXTEND TO A HEIGHT OF 6" FOR 15" AND 18" DIA. PIPE AND A MINIMUM 1/3 DIA. FOR 24" DIA. PIPE. THE BENCHES SHALL BE FLAT ON TOP, THE EDGES AND SHALL SLOPE TO THE INVERT OF THE CATCH BASIN.
3. THE OUTSIDE CROWN OF PIPE ENTERING OR LEAVING A CATCH BASIN SHALL BE BELOW THE ELEVATION OF THE BOTTOM OF FRAME.

TYPICAL PERIMETER BEAM SECTION

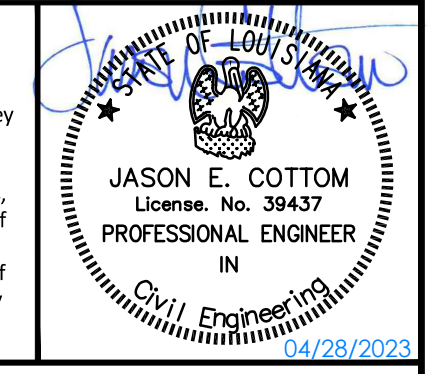

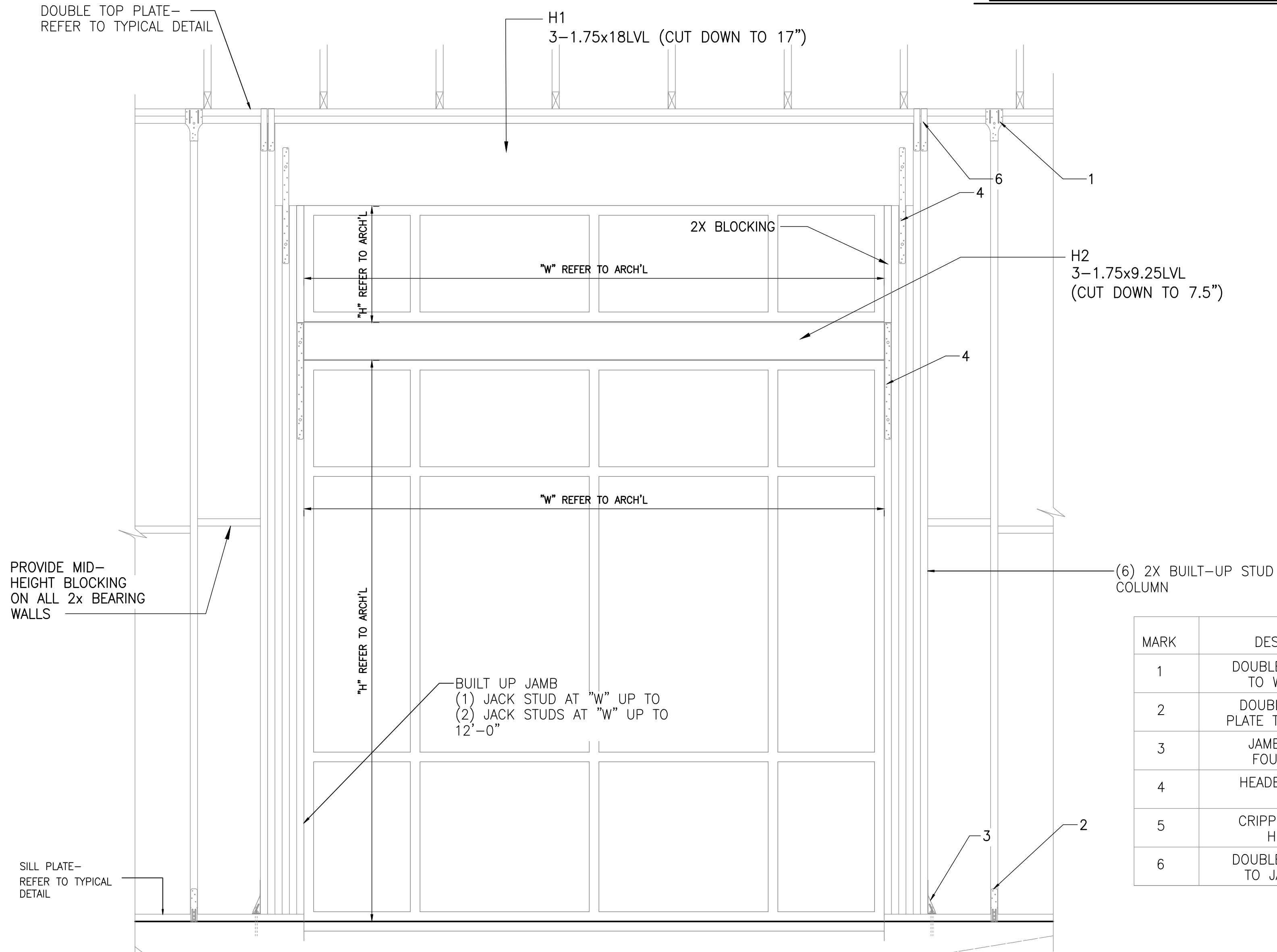
TYPICAL EXTERIOR WALL HEADER DETAIL

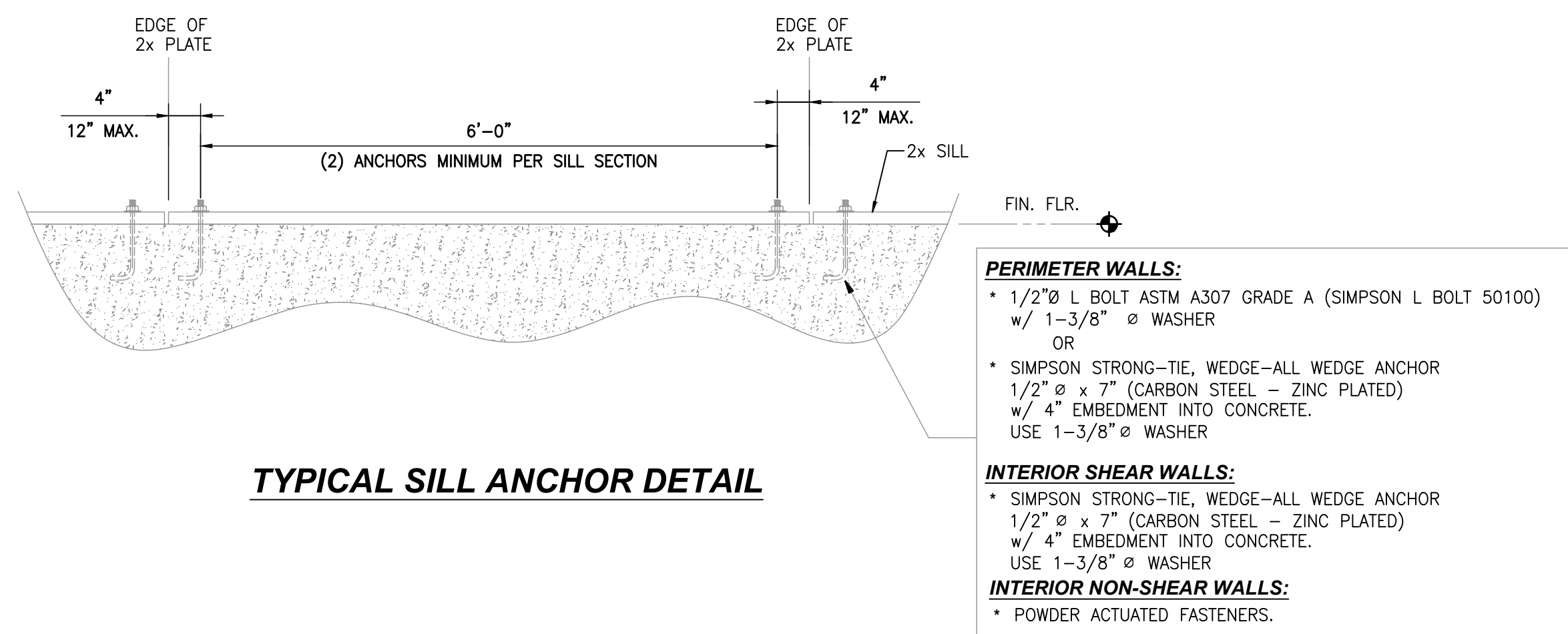
TYPICAL ROOF SHEATHING NAILING PATTERN

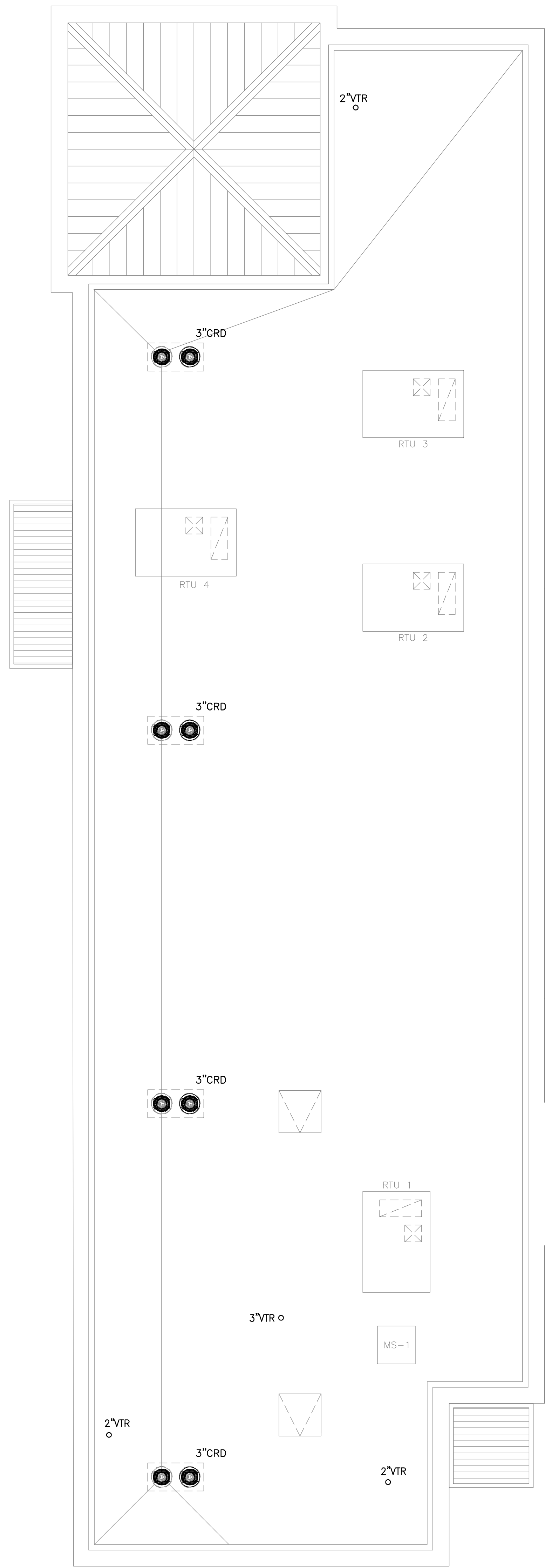
SITE PLAN PLUMBING 1/8"=1'-0"



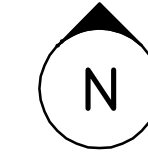
FLOOR PLAN PLUMBING 1/4"=1'-0"



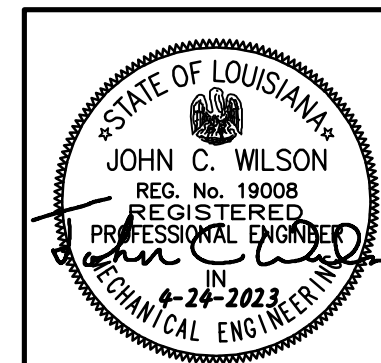

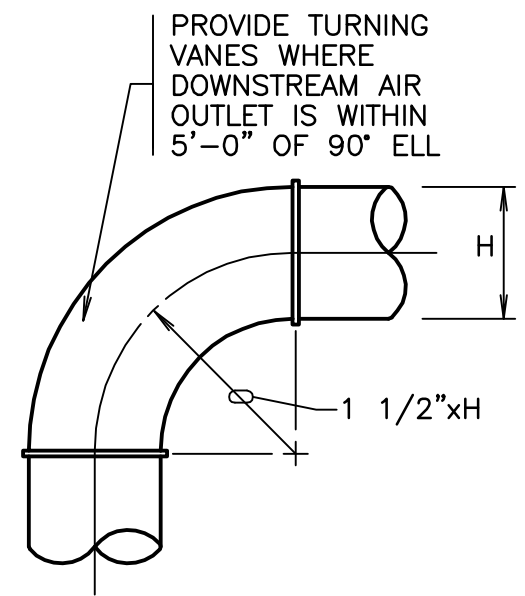

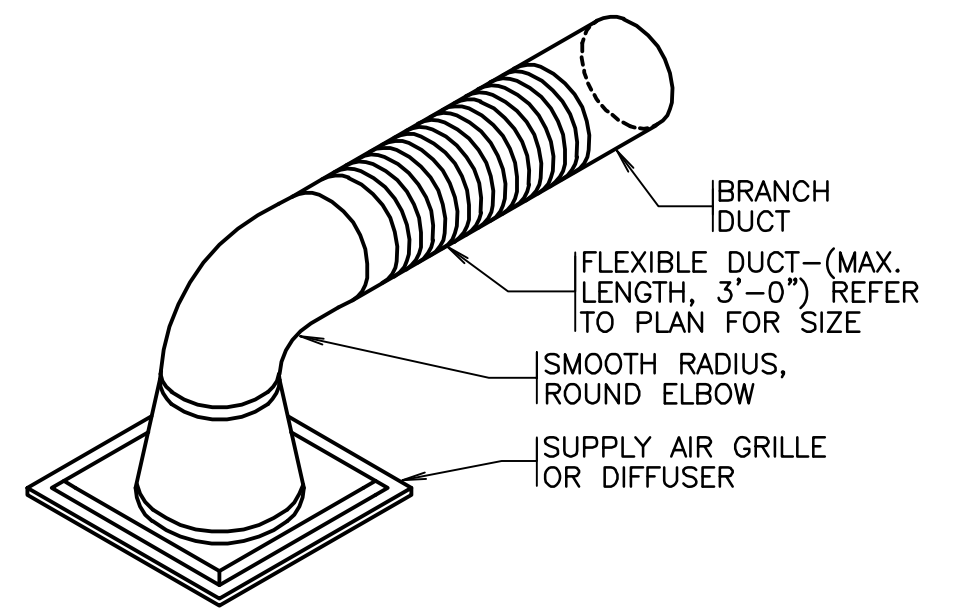

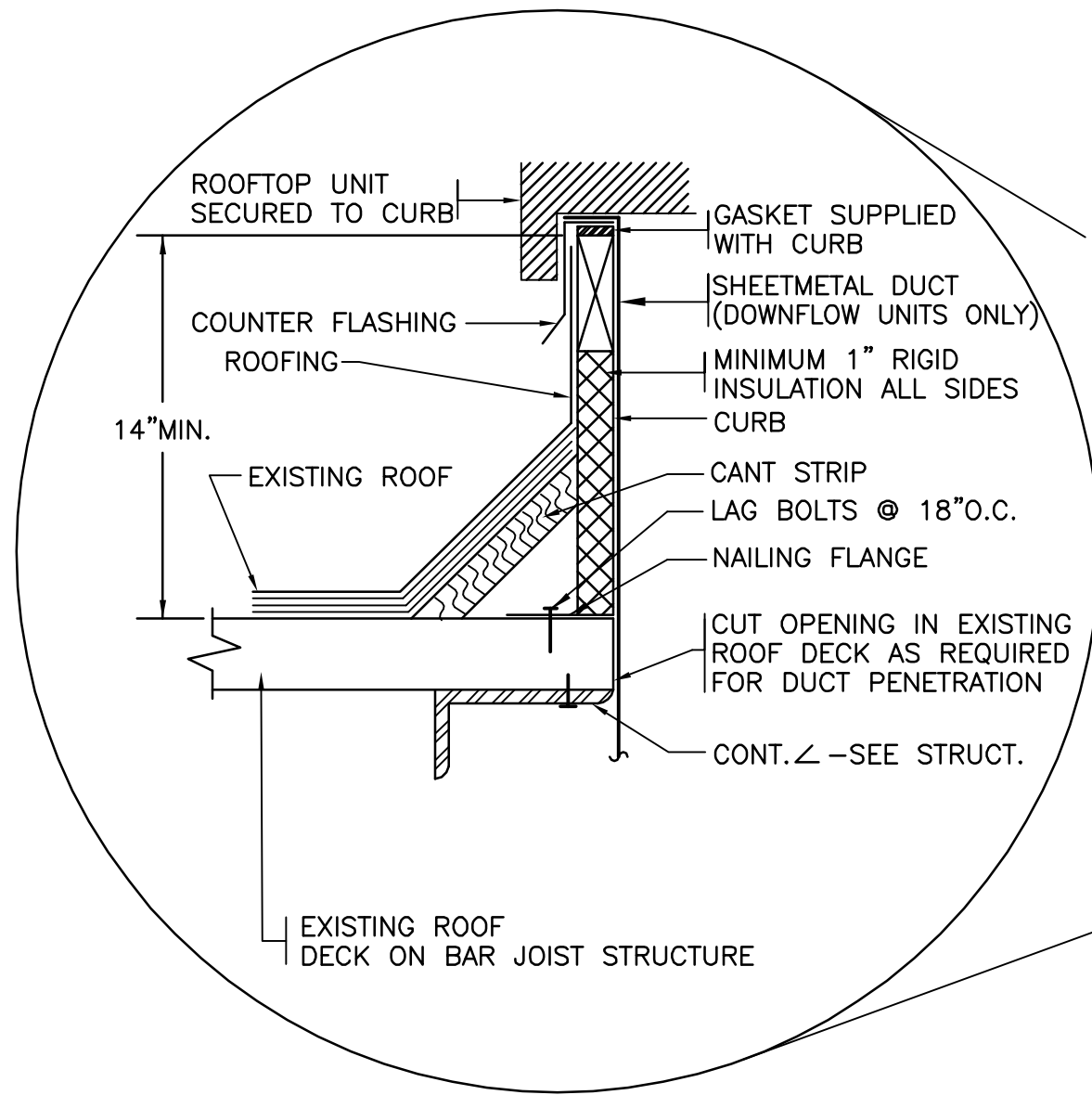

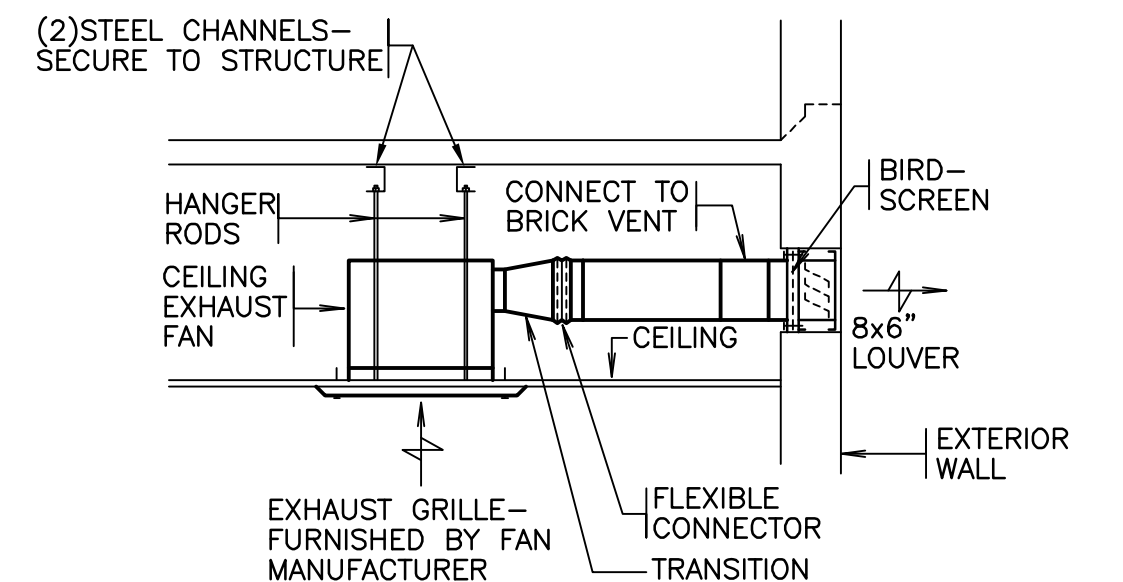


H DETAIL—TYPICAL BRANCH

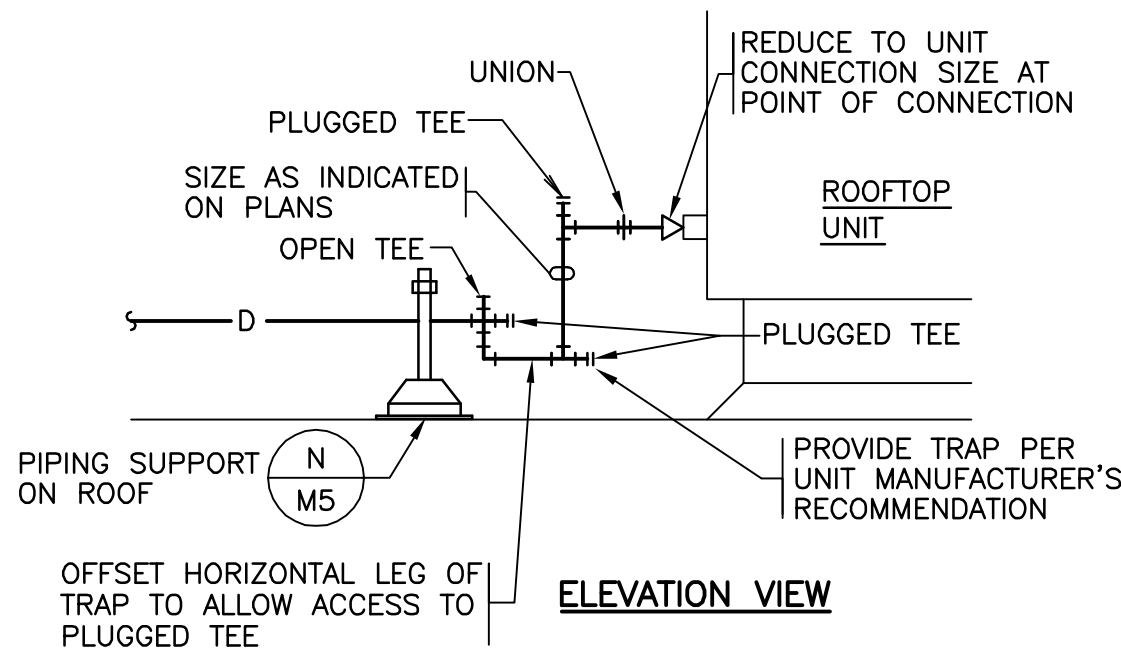


I DETAIL—TYPICAL ROOFTOP A/C UNIT CONNECTION

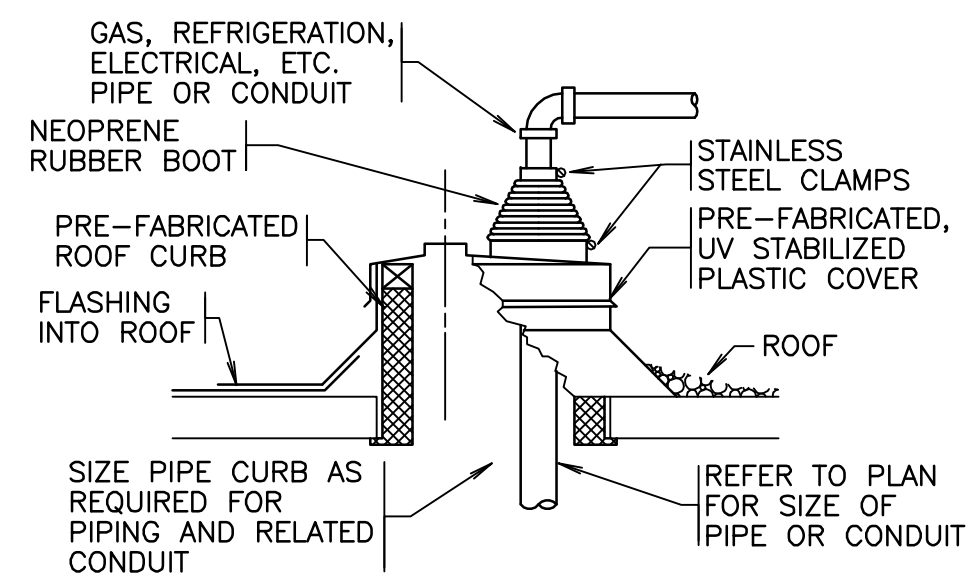

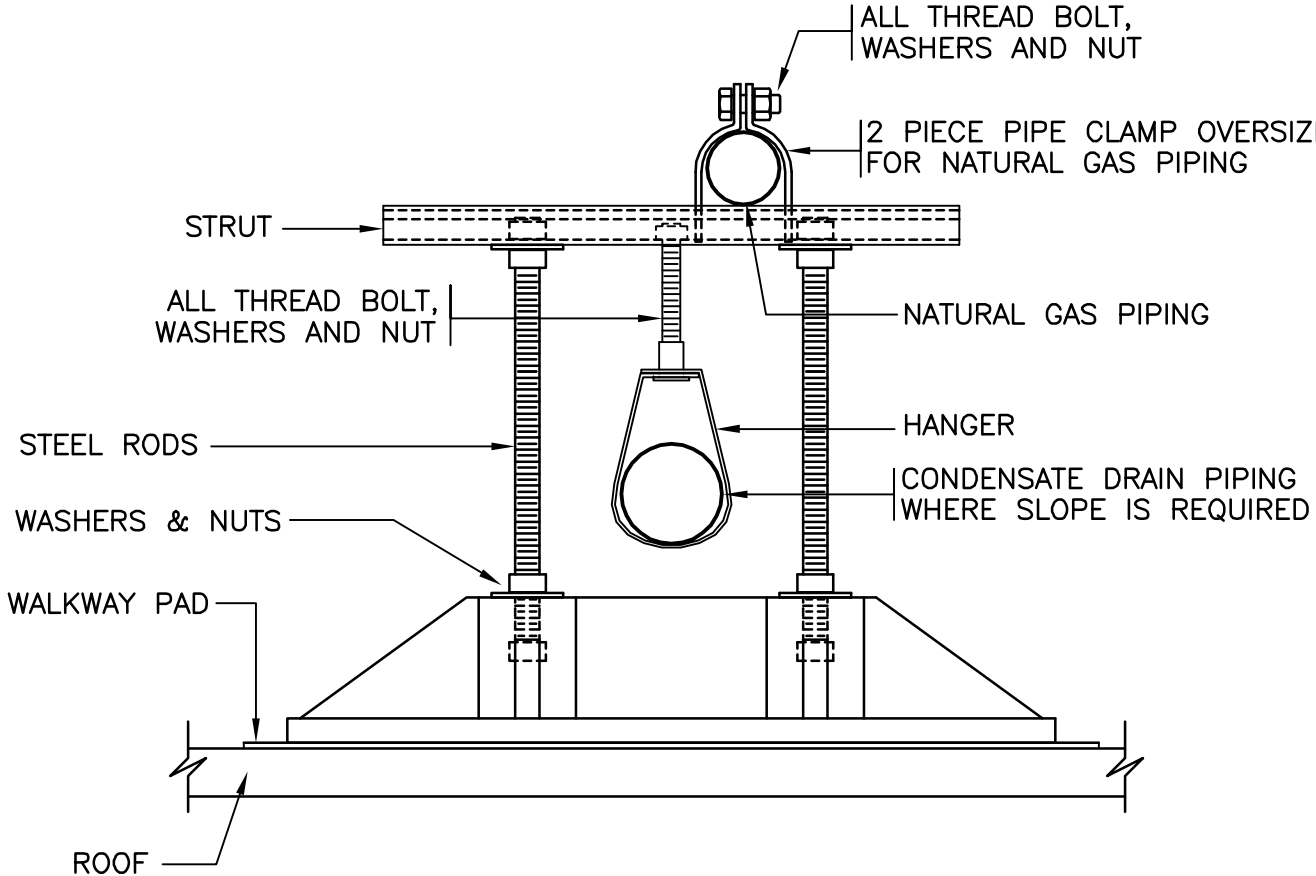

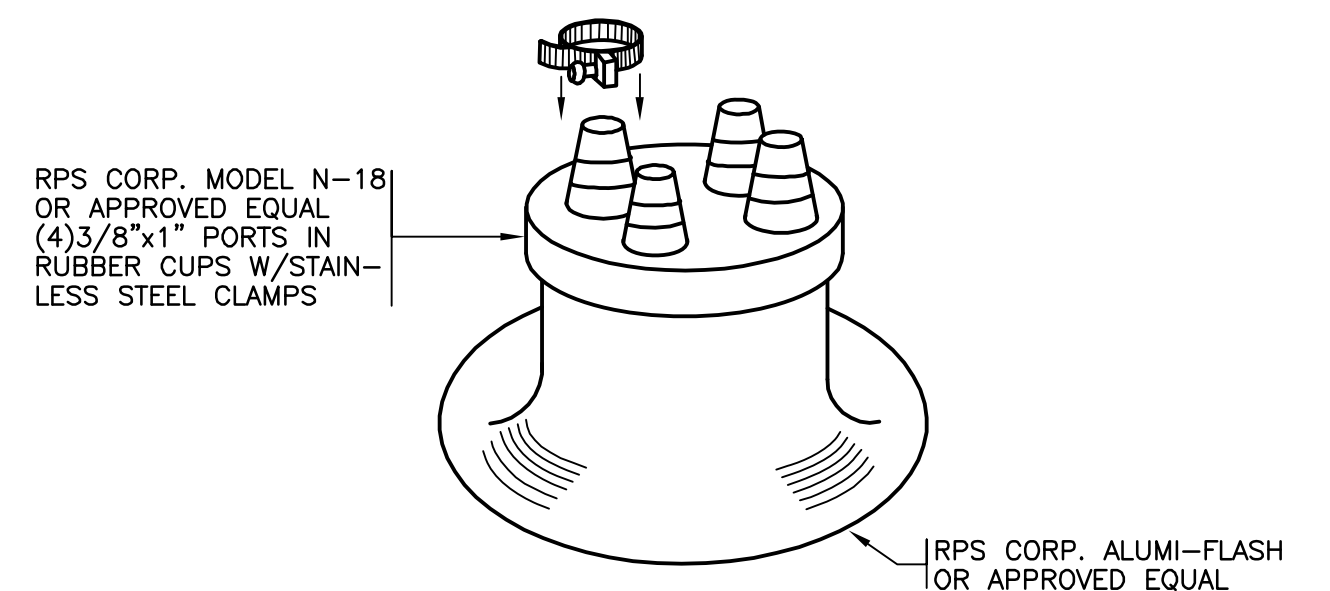


M DETAIL—PIPE CURB

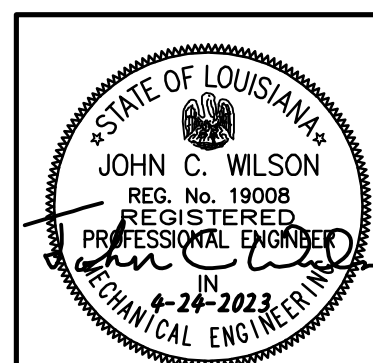




1. DRILL, TAP, AND SPLICE JOINTS USING FULL SIZE BAR AND 4 BOLTS.
2. PROVIDE FULL CAPACITY FLEXIBLE COPPER BRAIDED STRAP AT CORNERS.
3. PROVIDE #2/0 STRANDED COPPER GROUND WIRE BETWEEN BUS AND GROUND ROD. PROVIDE COMPRESSION END TERMINAL AT CONNECTION TO BUS.



1. DISCONNECT, RECEPTACLE, RACEWAYS, BRACKETS, ETC., AND WIRING SHALL BE INSTALLED SO THAT IT DOES NOT INTERFERE WITH EQUIPMENT OPERATION OR ANY REQUIRED MAINTENANCE FUNCTION.
2. RECEPTACLE AND CONTROL CONDUITS SHALL ENTER UNIT IN THE SAME MANNER AS SHOWN FOR POWER CONDUITS.
